On 5/6/2019, at approximately 1150 hours, I was working Marked Squad 481, P#76678, with Officer [REDACTED], we were both wearing BWC's.

We were contacted by Officer [REDACTED] in regards to a Narcotics Investigation he was conducting. He informed us that a vehicle would be arriving in the area of Olson Hwy and Morgan Ave No., with a large amount of Oxycodin pills.

At approximately 1155 hours, we were informed to stop and arrest all parties inside a Maroon Ford Explorer, with unlicensed plates. We drove into the area and observed the Maroon Ford Explore without plates drivng E/B on Olson Hwy from Morgan Ave No. We then activated the overhead lights and made a traffic stop on the vehicle. The vehicle turned N/B on James Ave No., and the vehicle stopped. There were (2) parties in the vehicle, the driver/AP [REDACTED] and the passenger/AP Floyd.

We approached the vehicle, ordered them to turn the vehicle off and then exit the vehicle. The driver/AP [REDACTED] was removed first. I then approached on the passenger side of the vehicle and met with passenger/AP Floyd. AP Floyd was moving all around and acting extremely nervous and would not listen to my commands. I continued to order him several times to stop moving around and to see his hands. AP Floyd had also put something in his mouth and was attempting to eat them. He was informed to spit what he had in his mouth out, but had already ate them.

Officer [REDACTED] and myself then had to physically remove AP Floyd from the vehicle and then handcuff him. AP Floyd continue to talk and then began to cry. I conducted a pat-down search and during the search, I felt a budge in his stomach area and removed a white napkin. The napkin contained several pills of Oxycodin. AP Floyd also had cash in both his front pockets. I removed and recovered the cash. The cash amount was \$594.00. AP Floyd was walked over to the squad, while walking him to the squad, (2) Oxycodin pills fell out of his pant leg to the ground. The pills were recovered and put with the other pills found on AP Floyd.

After AP Floyd was placed in the rear of the squad, I then went back up to the passenger side of the vehicle and in plain view could see several Oxycodin pills on passenger seat. I observed a brown pouch on the passenger floor board and picked it up and opened it. Inside the brown pouch was found several packages of pills and powder cocaine. I also found paperwork with the name of AP

Floyd inside. The brown pouch was recovered. The brown pouch was later given to Officer [REDACTED] for weighing and testing.

I was then informed to driver the vehicle back to the 4th Pct for further searching. I drove the vehicle back to the 4th Pct and searched the vehicle and found and recovered (5) five Oxycodin pills on and underneath the passenger seat where AP Floyd was sitting.

The pills that was recovered from the vehicle were given to Officer [REDACTED]
